CALL FOR APPLICATIONS FOR ONE RESEARCH SCHOLARSHIP IN EDUCATION FIELD

It is open a Call for Applications for one research scholarship for the project ***Here I find myself and I mix with people from all over the world*** (Título em português AquiMeEncontro – *Aqui me Encontro e confundo com gente de todo o Mundo*, Ref- 2023.10269.S4P23), financed by PRR – Programa de Recuperação e Resiliência, through PlanAPP, under the following conditions:

- 1. Admission requirements:** To apply for the research grant, applicants must comply with the following requirements, for which documentary evidence must be provided:
 - a) A degree in education; b) Experience in the use of Statistical and content analysis software; c) Fluency in written and oral Portuguese and English languages.
- 2. Time and Work Regime:** Time duration of the Research Scholarship will be 3 months from the beginning of the project that should be May 15th., 2025. The work will be carried out at the Laboratório de Educação a Distância e eLearning (LE@D) da Universidade Aberta, located at Universidade Aberta, Rua Almirante Barroso, 38, 1000-013, Lisboa. However, part of the tasks could be developed at distance. Work will be done in exclusivity of functions.
- 3. Research field / Scientific area:** Education.
- 4. Work plan:** Preparation of quantitative data for statistical analysis; preparation of qualitative data for content analysis; assistance concerning data analysis work. Participation in the data discussion; participation in writing project results for scientific publications and reports.
- 5. Scientific Supervision:** The work will be carried out under the scientific supervision of Prof. Doctor Ana Maria Mouraz Lopes.
- 6. Academic training:** Degree in Education.
- 7. Criteria:** a) Relevance of previous experience in research projects; b) Relevance of eventual publications in educational journals with peer reviewing; c) Experience in the use of statistical and content analysis software; d) Fluency in written and oral English (minimum level B/2) and in Portuguese language (minimum C/2).
- 8. Evaluation methods:** When evaluating the candidates' CV, in particular scientific experience and scientific merit, the elements presented will be valued according to the following criteria: a) Previous experience as settled criteria (60%); b) Integrated assessment of the candidate's curricular trajectory, based on an overview of his/her scientific merit (40%).
- 9. Monthly maintenance allowance amount:** The monthly maintenance allowance is 1.040,98 €, according to the table of values attached to the Regulation of Scholarships of the Foundation for Science and Technology. Payment will be made by Universidade Aberta by bank transference. In addition, the grant holder will be covered by personal accident insurance as established by law. - 10. Selection panel:** President: Ana Maria Mouraz Lopes; effective members: Ana Patrícia Almeida; Ana Nobre; alternate member: Marta Abelha.

11. Submission of applications:

The following documents are mandatory, under penalty of exclusion from the Call: Curriculum vitae; Letter of motivation indicating availability to start the Work Plan; Citizen card or passport; Degree certificate. (A recognition of the degree in case it was obtained in a foreign Higher Education institution - this recognition can be delivered until the act of hiring); Any documents that the candidates consider to be relevant for the assessment of their merits.

12. Applications should include the reference “AquiMeEncontro-02”. The Call for Applications is open from March 10th, until March 28th, 2025 (18:00, Lisbon time). Applications must be submitted exclusively by email, to the following address: lead@uab.pt with copy to ana.lopes@uab.pt.

13. Disclosure of the results: Evaluation results will be communicated by email to the address provided by the candidates in the Curriculum Vitae.

14. In compliance with the provisions of the Code of Administrative Procedure (“Código do Procedimento Administrativo”), after being notified, candidates have 10 working days, from April 14 until April 30th, to submit a formal rebuttal. The final decision must be taken after the conclusion of the preliminary hearing of interested parties.

15. The model of contract to be established between the candidate and the Universidade Aberta follows the rules of FCT for such cases.
